Treasurer's Report - Addendum

June 27, 2019

Review of financial information provided by SSES:

This morning ,June 27, I received an email containing spreadsheets from Andrew Sudderth (SSES Treasurer) showing the 2019 financials through May 2019 and draft budgetary information for the coming year, 2020. I have not had an opportunity to review these documents in detail, however, a cursory review raises a number of questions that need to be addressed by those constructing these documents. I urge the Vestry to have SSES present the school financials, budget and a cash flow statement at their earliest convenience. Some of the questions I had after my cursory review include:

- Understandably, the 2019 financials show results though May and, year to date, a \$23,942.93 Net Loss. With approximately 80 enrollees (per Andrew Sudderth) for 2019 it appears likely that SSES will incur a loss of at least \$76,000 once June results are posted. It is my understanding that little to no revenue will be coming in and salary costs for those electing a twelve month payout will continue.. Through April SSES had tapped the Kay Delcher Fund for \$53,293 of the \$77,840 budgeted to cover expenses. It is not clear whether or not they will absorb the entire budgeted amount to fund the current year's operations. Regardless, The Kay Delcher Fund will likely not be available to bridge any shortfall going forward.
- Current enrollment for 2020 is 62 (18 less than 2019). Mr. Sudderth is confident that 2020 enrollment can reach the 80 levels of the current year. Keep in mind, however, that the current year is likely to end up with a significant loss even with relief from the now exhausted Kay Delcher Fund.
- The draft budget provided does not make sense. It assumes \$93,000 in expense reductions at both the 62 ad 80 enrollment levels. Some of the costs involved must be variable to some degree. Based on reduced expenses and increased tuition, SSES is projecting a Net Loss ranging from \$8,217 (80 enrollees) to \$117,310 (62 enrollees).
- In 2019, SSES fund raising for the Extravaganza and Golf Tournament fell short of projections yet the draft 2020 budget anticipates those levels will be attained in 2020. How?
- A significant portion of the 2019 fund raising effort was the Annual Fund "Paver" project. I do not see where the costs associated with that project have hit the 2019 financials.

I do not have a feel for the flow of cash at the school, hence the need for a cash flow statement to ensure cash on hand to meet payroll and other expenses. In summary, we need to understand the assumptions made for and the marketing plan in place supporting the 2020 school year.

If anyone of you have thoughts on replacing these two valuable people, please bring them to the table.

We've accomplished quite a bit the first half of the year – congratulations! We will take a break in July (unless something unexpected happens) and will resume in August. Have a great summer and stay cool.
